**JUDGING ORDER:** The run order in a class will be the order in which entries are received. Dogs will be run in height order, except when multiple entries of the same handler require separation. When possible, dogs will be staged in groups of 5 or less.

**CONFIRMATION OF ENTRY:** The receipt of entries will be confirmed only for those providing a return e-mail address on their form.

**VALIDATION OF ENTRIES**: Entries <u>must</u> be complete, with entry fees, and signed Waiver/Participation Agreement included in order to be considered Valid entries. Entries submitted without payment or without the agreement filled in and signed will be refused participation. Entries with an INCORRECT DOG ID <u>will not</u> be considered valid.

**MOVE UPS:** Move ups are up to the handler and not required. Move-ups will be accepted until 10 min after the conclusion of the relevant Trial/class. You must complete the *Move-up form* available at the secretary's table and pay any additional fees if applicable.

**AWARDS:** Ribbons for all qualifiers, Placement Rosettes for 1st-4th in Novice, Open, Senior & Master classes in each height division, Dogs that earn a Barn Hunt title RATN or higher will receive a title



rosette. High in Class ribbons will be offered in Novice, Open, Senior and Master. Additional Prizes May be Offered.

**TRIAL SITE:** Building will be open 30 min. before start time. These trials are being held in a covered unheated/cooled building with a sand/dirt floor. It is wheelchair accessible. Port-a-Potty will be on site, it is not wheelchair accessible. Blinds are in the building 12 x 14 enclosed area with a solid divider between dogs. Please come prepared for Ottawa weather. Dogs must be crated outside or in vehicle, please bring everything your dog will need to be comfortable. **Dogs will not be allowed in the building unless being tested.** Lots of Room on site for pop up tents and X-pens.



**PARKING:** Ample parking will be available on site.

**REFUNDS AND WAITLISTS:** Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, and public emergency, act of a public enemy or any other causes beyond the control of the trial committee.

Withdrawals after the pre-entry closing date due to injury of the dog will be eligible for a refund of entry fees paid upon receipt of a note from your veterinarian. The note must be dated and emailed or mailed to the Trial Secretary prior to the close of the trial. For persons withdrawing after the pre-entry closing date NO refund will be provided unless the club has a wait list to fill the spot. ### **NOTICE TO EXHIBITORS:**

- Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then you cannot enter the Instinct Test.
- Height Divisions: Small, Dogs 13" & under; Medium, Dogs 13.1" to 18"; Large, Dogs over 18". It is the exhibitors responsibility to know their dogs' height and enter in the correct class.
- All dogs must be on leash at all times except when in the ring for judging. Dogs must run "Naked" in the ring, it is strongly encouraged that the collar/harness be of a type that is easily removed and replaced in the ring.
- Wear appropriate footwear and clothing for the outdoors.
- You must be mindful of other exhibitors and keep your dog close to you, under control and on a short leash. Altercations are subject to Barn Hunt rules and can result in teams being ejected from the trial or being banned from the sport.

# PLEASE WATCH YOUR DOG AND GIVE DOGS SPACE NO FLEXIS, HEAD HALTERS OF E-COLLARS IN USE.

- Exhibitors are responsible to clean up after their dogs.
- Loud/Disruptive dogs: may be asked to park in a separate location in order to minimize disruption to other



competitors

- Crates and x-pens must be secure in order to prevent dogs from escaping. Dogs may get highly excited at the trial.
- All posted signs must be respected.
- Children are welcome but must be under strict supervision at all times. If their behavior is disruptive, you will be asked to leave the property
- Gableridge Barn Hunt will use care and diligence for the safety and welfare of the dogs, the exhibitors, the spectators and the quarry, but will not be responsible for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.
- Gableridge Barn Hunt reserves the right to refuse any entry for any reason. This includes just cause, repeated bounced entry cheques or unsportsmanlike conduct among other reasons. You will be notified by email or in person and your entry fee will be returned.

**BITCHES IN SEASON:** Bitches in season (BIS) MAY compete at Barn Hunt trials. They will be run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course.

Owners of BIS should seek out the chairperson upon arrival to be parked in the BIS parking/walking area. Advance notice is greatly appreciated!

Failure to notify the Trial Sec, Club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.

**DOG AGGRESSION:** Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee
